**S. R. O. No. 8/2018.**—In exercise of the powers conferred by section 5 of the Kerala Shops and Commercial Establishments Act, 1960 (34 of 1960), the Government of Kerala, being satisfied that the public interest so requires, hereby exempt the two establishments of Titan Eye + of Titan Company Ltd. in Ernakulam as detailed in the schedule below from the operation of the provisions of sub-section (1) of

section 11 of the said Act, for a period of one year from the date of publication of this notification in the Gazette, subject to the following conditions, namely:—

- (1) Every person employed in the establishments should be provided with all benefits under Labour Laws.
- (2) Every person employed in the establishments should be allowed a weekly holiday with full wages as envisaged in sub-section (2) of section 11 of the said Act.
- (3) The Register of employment under sub-rule (1) of rule 10 of the Kerala Shops and Commercial Establishments Rules, 1961, must properly be kept in the establishments and should be produced before the Labour Officers for inspection as and when requested by them.
- (4) Every person employed in the establishments should be allowed interval for rest as envisaged in section 8 of the said Act.
- (5) Every person employed in the establishments should be given overtime wages as envisaged in section 7 of the said Act.
- (6) The working period of every person employed in the establishments should not be exceeded over ten and a half hours including spread over, as envisaged in section 9 of the said Act.

The exemption granted is liable to be cancelled for violation of all or any of the above conditions.

**Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

As per section 5 of the Kerala Shops and Commercial Establishments Act, 1960 (34 of 1960) the Government may, if they are satisfied that public interest so requires or that the circumstances of the cases are such that it would be just and proper to do so having regard to the nature and capacity of the establishment, by notification in the Gazette, exempt either permanently or for any specified period, any establishment or class of establishments in any area or persons or class of persons to which or to whom this Act applies, from all or any of its provisions subject to such restrictions and conditions as the Government deem fit. Accordingly, Government have decided to exempt the two establishments of Titan Eye + of Titan Company Ltd. in Ernakulam for a period of one year from the date of publication of this notification from the provisions of sub-section (1) of section 11 of the said Act.

The notification is intended to achieve the above object.
