No. 615/2017.—In exercise of the powers conferred by section 3 of the Kerala Headload Workers Act, 1978 (20 of 1980), read with section 21 thereof, the Government of Kerala hereby appoint Shri K. G. Valsalakumar, the District Labour Officer, Vizhinjam Port Project, Thiruvananthapuram to be the Conciliation Officer for the purpose of performing the functions entrusted to the Conciliation Officer by or under the said Act, in the territorial area of Vizhinjam International

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Section 3 of the Headload Workers Act, 1978 (20 of 1980) empowers the Government to appoint for any area specified therein any officer of the Labour Department not below the rank of Deputy Labour Officer to be a Conciliation Officer for the purpose of performing the functions entrusted to the Conciliation Officer by or under the said Act. The Government vide G. O. (Ms.) No. 8/2017/LBR dated 17th February, 2017 have created a new Post of District Labour Officer exclusively for settling labour related matters that may arise in the territorial area of Vizhinjam International Seaport Project. It is found expedient to have the District Labour Officer, Vizhinjam Port Project, Thiruvananthapuram appointed as Conciliation Officer under Section 3 of the said Act so as to perform the functions entrusted to him under Section 21 of the said Act in relation to settlement of any disputes falls within the ambit of the said Act, in the territorial area of Vizhinjam International Seaport Project, being constructed by, operated or maintained by M/s Adani Vizhinjam Port Private Limited. Accordingly Government have decided to appoint Shri K. G. Valsalakumar, District Labour Officer, Vizhinjam Port Project, Thiruvananthapuram as Conciliation Officer for the purposes of the said Act.

The notification is intended to achieve the above object.
