The following draft Regulations further to amend the Kerala Trade Union Regulations, 1958 which Government of Kerala proposes to make in exercise of the powers conferred by sub-subsection (1) of section 29 of the Indian Trade Unions Act, 1926 (Central Act XVI of 1926) are hereby published as required by sub-section (1) of section 30 of the said Act for general information of all persons likely to be affected.

Notice is hereby given that the said draft will be taken up for consideration on or after three months from the date of publication of this notification in the Gazette and that objections and suggestions, if any, that may be received from any person with respect to the said proposal on or before the date specified above, will be considered by the Government. All objections and suggestions shall be



addressed to the Additional Chief Secretary to Government, Labour and Skills (E) Department, Government Secretariat, Thiruvananthapuram - 695 001.

DRAFT REGULATIONS

1. *Short title and commencement.*-(1) These regulations may be called the Kerala Trade Unions(Amendment) Regulations, 2019.

(2) They shall come into force at once.

2. *Amendment of the Regulations.*-In the Kerala Trade Union Regulations, 1958,-

(1) in regulation 3A, for the words "sixty days", the words "thirty days" shall be substituted;

(2) after regulation 4, the following regulation shall be inserted namely:-

"4A. *Time limit for registration.*- Every application duly submitted for registration of a trade union in accordance with section 5 shall be disposed within 30 days"

(3) in regulation 5, for the words "one thousand rupees", the words "ten thousand rupees" shall be substituted;

(4) in clause 3 of regulation 17, in item (ii), for the words "two hundred and fifty rupees", the words "five hundred rupees" shall be substituted.

(5) in regulation 27,-

(a) in clause (i) for the words "Naya paise fifty", the words "Rupees ten only", shall be substituted;

(b) in clause (ii) for the words "Naya paise fifty", the words "Rupees ten only" shall be substituted.
