ORDER

The Provisional Seniority List of Deputy Labour Commissioner's as on 30-11-2018 has been forwarded to the Labour Commissioner, vide Government letter read 2nd paper above for being circulated among the officers concerned for filing objections if any, with regard to seniority assigned to them. The Labour Commissioner, Thiruvananthapuram in the letter dated 25-1-2020 has reported that Shri. R. Pramod, Chief Inspector of Plantations, Shri. Biju, K. S., Joint Labour Commissioner (Presently working as Chief Executive Officer, Kerala Shops and Commercial Establishments Workers Welfare Board), Shri. Mahesh T. Pai, Regional Joint Labour Commissioner (Presently working as Chairman, Cochin Port Trust Area), Shri. B. Arun, Deputy Labour Commissioner (now working as Joint Labour Commissioner) have raised objections against to refix the seniority of Shri. Sunil Thomas, Deputy Labour Commissioner as Serial No. 8 in between Serial No. 7 Shri. K. M. Sunil and Serial No. 9 Shri R. Pramod. In this regard a

hearing was conducted on 4-3-2020. The main argument raised in the hearing by the above officers is that Note (iii a) below Rule 28 (b) (i) (7) Part II KS&SSRs and Rule 27B Part II KS&SSRs prohibits the restoration of seniority of Shri. Sunil Thomas, Deputy Labour Commissioner.

- 2. Government have examined the objections raised by the above officers in detail and found that the time limit fixed for revision of Select List in Note (iii a) cannot be made applicable to the officers in Note (i), who are subsequently fully exonerated. This position has been upheld by the Hon. High Court of Kerala in the Para 8 of the Judgment dated 25-3-1994 in O.P. No. 13644/1993 [Narayana Pillai Vs State of Kerala 1994 (1) KLT 1020]. As per Note below sub-rule (8) (a) under Rule 28 (b) (i) of Part II KS&SSRs, promotion from the 1st Select List is provisional and it can be revised at any time, if it is found necessary. Promotion to Selection posts are specifically governed by Rule 28 (b) (i) Part II KS&SSRs. In this case, as Shri. Sunil Thomas is completely exonerated, the first two sentences in the Note (ii) below Rule 28 (b) (i) (7) Part II KS&SSR is applicable and his case cannot be determined under Rule 27B Part II KS&SSRs. Hence the objections raised by the above officers against the seniority list is rejected and seniority of Shri. Sunil Thomas is restored.
- 3. In the above circumstances, Government are pleased to finalize the seniority list of Deputy Labour Commissioner's as on 31-11-2018 as appended to this order.
