In exercise of the powers conferred by sub-section (1) of section 34 of the Kerala Shops and Commercial Establishments Act, 1960 (34 of 1960), the Government of Kerala, after being previously published the draft rules calling for objections and suggestions as per the notification No.LBRD-E3/19/2021/LBRD dated 13th September, 2021 and published in the Kerala Gazette Extraordinary No.2707 dated 16th September, 2021 as required under sub-section (4) of section 34 of



the said Act, hereby make the following rules further to amend the Kerala Shops and Commercial Establishments Rules, 1961, namely:-

RULES

- 1. Short title and commencement.- (1) These rules may be called the Kerala Shops and Commercial Establishments (Amendment) Rules, 2021.
 - (2) They shall come into force at once.
- 2. Amendment of the Rules.- In the Kerala Shops and Commercial Establishments Rules, 1961, in sub-rule (1) of rule 2G, for the existing Table, the following Table shall be substituted, namely:-

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the notification issued under G.O.(P)No.86/2013/LBR dated 16th July, 2013 and published as S.R.O.No.572/2013 in the Kerala Gazette Extraordinary No.2157 dated 23rd July, 2013 the Government have revised the rates of fees payable under sub-rule (1) of rule 2G of the Kerala Shops and Commercial Establishments Rules, 1961 with effect from 23rd of July, 2013.
