In exercise of the powers conferred by clause (a) of sub-section (1) of section 5 read with section 9 of the Minimum Wages Act, 1948 (Central Act 11 of 1948), the Government of Kerala, hereby make the following amendment to the notification issued under G.O.(P) No.86/2023/LBR dated 11th October, 2023 and published as S.R.O. No.1090/2023 in the Kerala Gazette Extraordinary No. 3350 dated 12th October, 2023 namely:-

## **A**MENDMENT

In the last paragraph of the said notification, after the last sentence, the following sentence shall be added, namely:-

"The Travelling Allowance claims on behalf of the members of the Committee shall be met from the head of account "2230-01-101-98" and the Additional Labour Commissioner, (Enforcement), Labour Commissionerate shall be the authority to countersign the Travelling Allowance bills of the members."

#### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government had constituted a Committee to hold enquiries and advise the Government in respect of revision of minimum rates of wages payable to the employees employed in the Private Hospital sector in the State of Kerala as per the notification issued under G.O.(P) No.86/2023/LBR. dated 11<sup>th</sup> October, 2023 and published as S.R.O. No.1090/2023 in the Kerala Gazette Extraordinary No. 3350 dated 12<sup>th</sup> October, 2023. Now, the Government have decided to incorporate the details of Head of Account and the counter signing authority in respect of processing TA Bills of the members of the said Committee and to amend the said notification suitably.

The notification is intended to achieve the above object.
