	How to register a Motor Transport undertaking
	<i>Online Application along with fee and copy of RC Book before the Inspector under MTW Act (Assistant Labour Officer) thirty days before the date of operation of the undertaking</i>
	What is the prescribed fees under the Act
	<p><i>Fees is As per the minimum number of motor transport workers to be employed on any one day during the year</i></p> <p><i>Up to 5 workers- ` 500</i></p> <p><i>Above 5 and up to 10 workers- ` 750</i></p> <p><i>Above 10 and up to 20 workers- ` 1,000</i></p> <p><i>Above 20 and up to 30 workers- ` 2,500</i></p> <p><i>Above 30 and up to 40 workers- ` 3,000</i></p> <p><i>Above 40 and up to 50 workers- ` 4,500</i></p> <p><i>Above 50 and up to 75 workers- ` 6,000</i></p> <p><i>Above 75 and up to 100 workers- ` 7,500</i></p> <p><i>Above 100 and up to 200 workers- ` 10,000</i></p> <p><i>Above 200 and up to 500 workers- ` 15,000</i></p> <p><i>Above 500 and up to 750 workers- ` 25,000</i></p> <p><i>Above 750 and up to 1000 workers- ` 30,000</i></p> <p><i>Above 1000 workers- ` 50,000</i></p>
	How and when to renew the Registration
	<i>Repeat the procedure in item No. 2 Submit along with the original RC before sixty days of the date of expiry. 25% of the fee shall be paid in the case of belated applications for renewal.</i>
	Is there any prescribed wages for the Motor Transport workers
	<i>Govt. have notified fair wages for the workers of Motor Transport undertakings</i>

	Total number of working hours of a worker.
	<i>8 hrs in a day and 54 hrs in a week. This may be extended to 10 hrs in a day and 50 hrs in a week with prior permission of the Chief Inspector</i>
	How many days of leave available for a Motor Transport Worker
	<i>Leave with wages one day for every 20 days to a workman who worked for a period of 240 days or more in the year immediately proceeding.</i>
	Welfare amenities to be provided to a workman
	<i>Canteen, rest room, first aid and uniforms.</i>
	What are the registers and records to be maintained by MT undertaking
	<i>Register of workers in form IX Muster roll of workers in form X Overtime Muster roll in form XI Leave book in form VIII (Provided to worker) Register of leave with wages form VII Individual control book form XII</i>
	What is the penalty for violation of the provision of the Act & Rules
	<i>Imprisonment which may extend to 3 months or with fine which may extend to Rs. 500/- or with both</i>
