DRAFT RULES

1. *Short title and commencement.*- (1) These rules may be called Kerala Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Amendment Rules, 2024.

(2) They shall come into force at once.

2. *Amendment of the Rules.*- In the Kerala Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Rules, 1983,-

(1) in Rule 12,-

(a) in sub-rule (1), for the existing "TABLE", the following "TABLE" shall be substituted, namely:

(a) Is 5 but does not exceed 20	115
(b) exceeds 20 but does not exceed 50	175
(c) exceeds 50 but does not exceed 100	345
(d) exceeds 100 but does not exceed 200	575
(e) exceeds 200 but does not exceed 400	1,150
(f) exceeds 400	1,380"

(b) in sub-rule (2), for the existing "TABLE", the following "TABLE" shall be substituted, namely:

"TABLE"

(a) Is 5 but does not exceed 20	35
(b) exceeds 20 but does not exceed 50	60
(c) exceeds 50 but does not exceed 100	115
(d) exceeds 100 but does not exceed 200	230
(e) exceeds 200 but does not exceed 400	460
(f) exceeds 400	575
(g) Security deposit per workmen	2,300"



(2) in rule 16, for the letters, symbol, figure, words and brackets “Rs. 15 (Rupees fifteen only)”, the letters, symbol, figure, words and brackets “Rs. 55 (Rupees fifty five only)” shall be substituted.
