In exercise of the powers conferred by sub-section (1) of section 35 of the Contract Labour (Regulation and Abolition) Act, 1970 (Central Act 37 of 1970) the Government of Kerala, hereby publish for general information the following draft rules further to amend the Kerala Contract Labour (Regulation and Abolition) Rules, 1974.

Notice is hereby given that said draft rules will be taken up for consideration on or after 3



months from the date of publication of rules and any objection or suggestions that may be received from any person with respect to the said draft before the expiry of the period specified above, will be considered by the Government. Objections and suggestion, if any, shall be addressed to the Secretary to the Government, Labour & Skills Department, Government Secretariat, Thiruvananthapuram-695 001.

#### DRAFT RULES

- 1. Short title and commencement.- (1) These rules may be called the Kerala Contract Labour (Regulation and Abolition) (Amendment) Rules, 2025.
  - (2) They shall come into force at once.
- 2. Amendment of the Rules.- In the Kerala Contract Labour (Regulation and Abolition) Rules, 1974, -
- (1) In sub-rule (1) of rule 24, for the letters, symbol and figure "Rs.20", the letters, symbol and figure "Rs.200 shall be substituted;
  - (2) For rule 26, the following rule shall be substituted, namely:-
- "26. Fees.- (1) The fees to be paid for the grant of a certificate of registration under section 7 shall be as specified below, namely:-
