ORDER

Department for Promotion of Industry and Internal Trade, Ministry of Commerce and Industry, Government of India as part of State Business Reform Action Plan, 2024 recommended a series of reforms targeted at increasing transparency and improving efficiency and reducing burdensome compliances of the regulating framework and services for business in India. Presently the Industries/ traders/manufactures/shops etc., are required to obtain the Trade Licence named as License to Factories, Trades, Entrepreneurship Activities, and Other Services (IFTEOS License) from the Local Self Government Institutions under the Kerala Panchayat Raj (Issue of Licence to Factories, Trades, Entrepreneurship Activities and Other Services) Rules, 1996 or the Kerala Municipality (Issue of Licence to Factories, Trades, Entrepreneurship Activities and Other Services) Rules, 2011 and also registration of shops and establishment under the Kerala Shops and Commercial Establishments Act, 1960 and Rules framed there under;

This has come to the attention of the government that businesses are under a burden to comply with the mandatory requirement to submit the same documents under two different laws and has decided to reduce compliance burden due to duplicity through a common application form for applying for IFTEOS License from the Local Self Government Institutions of the state and simultaneously for the registration of shops and commercial establishment under the Kerala Shops and Commercial Establishments Act, 1960 and rules framed thereunder.

In this regard the Government as part of implementing the State Business Reform Action Plan, 2024 is pleased to mandate and hereby notify the, common application form to be filed for registration under the Shops & Establishment Act and IFTEOS License from the Local Self Government Institutions namely:
