ORDER

Department for Promotion of Industry and Internal Trade (DPIIT), Government of India has released the Business Reform Action Plan (BRAP) 2024, for ranking States based on the ease of doing business environment. The SB RAP 2024 contains 38 reforms associated with the Labour Department which mainly focus on the online service delivery of the Government to Business services of the departments and its integration with state online single window clearance system (KSWIFT).

2) Reform No.166 included in the SB RAP, 2024 is about ensuring Registration/Renewal of establishment under the provision of the Inter State Migrant Workmen (Regulation of Employment and Conditions of Service) Act-1979, issued electronically within such time failing which the license shall be deemed to be issued and shall be auto generated.

3) In order to foster an industrial-friendly atmosphere and reduce procedural delays, the Labour Commissioner, vide letter read as 2nd paper above, has requested the Government to accord sanction for issuance of deemed certifications for those applications, submitted in the prescribed manner and form along with relevant documents under the Inter State Migrant Workmen (Regulation of Employment and Conditions of Service) Act,1979 in which no such registration/license has been issued by the authority within a period of 15 days. Further, the Labour Commissioner has urged the Government to issue a formal order to include the implementation of changes in Labour Commissionerate Automated System(LCAS) to ensure the above facility.

4) After detailed examination, Government hereby order that the registering authority appointed under the Inter State Migrant Workmen (Regulation of Employment and Conditions of Service) Act-1979 shall issue/ reject the registration certificate within 15 days of making the application, failing of which the registration certificate shall be deemed to be issued and shall be auto generated.

5) Relevant provisions of the Kerala Inter State Migrant Workmen (Regulation of Employment and Conditions of Service) Rules, 1983 will be amended in due course.
