NOTIFICATION

G. O. (Ms.) No. 15/2014/LBR. Dated, Thiruvananthapuram, 5th February, 2014.

S. R. O. No. 96/2014.—In exercise of the powers conferred by clause (b) of sub-section (1) of section 3 of the Minimum Wages Act, 1948 (Central Act 11 of 1948) read with sub-section (2) of section 5 thereof and in supersession of notification G. O. (Rt.) No. 804/2009/LBR dated 12th June, 2009 published as S.R.O. No. 482/2009 in the Kerala Gazette Extraordinary No. 1055 dated 12th June, 2009, the Government of Kerala after considering the objections and sugestions received on the draft proposals published in Notification 25278/E1/2012/LBR dated 18th July 2013 in Kerala Gazette Extraordinary No. 2319 dated 3rd August, 2013 as required under clause (b) sub-section (1) of section 5 of the said Act and after consultation with the Minimum Wages

Advisory Board constituted under section 7 of the said Act hereby revise the minimum rates of wages payable to the classes of employees employed in Tea, Rubber, Coffee and Cardamom Plantations in the State of Kerala as specified in the Schedule hereto annexed. The rates as specified in Schedule I shall come into force with effect from 15-11-2011 and II to IV shall come into force with effect from 1-10-2011 respectively.

The term 'Factory' for this purpose means any place where a manufacturing process is carried on irrespective of the number of workers employed.

2. Piece Rated work

(c) Minimum piece Rate:

Pluckers in the Plantations shall be paid the following piece rates over and above the guaranteed time rates.

 ₹ 2.0656 per Kg for the 16 Kgs of harvested leaves during a day in January, February and August.

- 2. ₹ 1.5738 per Kg for the first 21 Kgs of leaves harvested a day in the other months of the year.
- 3. 60 paise per Kg. for the first 14 Kgs over and above the standard output and 85 paise per Kg for the next 14 Kgs and 110 paise per Kg thereafter.
- (d) Adjustments of piece rates:

Where the plucking average for an estate over a month is found to be less than the standard output, the wages for the month shall be paid at a revised piece rate calculated on the basis of the actual average for the month which should be taken as the standard. The rate should be such that after deducting 10% from the revised standard output, the remaining quantity will be the standard out put of the worker and an amount equal to the difference between the minimum wages and the guaranteed time rate of the worker shall be paid. A plucker shall be entitled to receive this rate for the leaves harvested on every day of that month up to the revised standard daily output for the month.

GENERAL (APPLICABLE TO ALL CROPS)

1. Fitment:

(Applicable to Supervisors and selected special Categories, other special Categories and attendants in all crops)

₹ 1040 in respect of supervisors and selected categories and ₹ 1025 in respect of other special categories and creche attendants to be added. On the basic salary in the pre-revision scale on the respective days of operation in Tea, Coffee, and Cardamom plantations (Pure) and ₹ 2545 and ₹ 2500 respectively in respect of rubber plantations and ₹ 1800 and ₹ 1730 respective in respect of Pure Plantations and pay in the Revised Scale of pay will be fixed in the nearest higher incremental step. (Tea as on 15th November, 2011, Cardamom and Rubber as on 1st October 2011).

The job deferential of ₹ 3.25 per day will be eligible to the following categories of workers:

- 2. Spraying Workers including mixing Workers
- 3 Tinkers
- 4. Telephone Operators
- 5. Dressers

19. Workers employed in actual regulation of shade in Cardamom Plantations on days on which they are employed in such work. Pruners will be paid a job differential of 38 paise per day on all working days through out the year (Tappalmen, Permanent cooks of Hospitals and Estate office peons who at present in receipt of job differential will be on daily rate until completion of one year of service and are eligible for the differential as above during the one year period).

II Service Weightage

- 1. Daily rated workers
 - (i) Below 5 years-Nil
 - (ii) Above 5 years and up to 10 years-60 paise
 - (iii) Above 10 years and up to 15 years-90 paise
 - (iv) Above 15 years and up to 20 years-120 paise

 - (v) Above 20 years-Four Additional increment.

III. Dearness Allowances

The basic wages mentioned above are equated to 400 of the new Consumer Price Index Number (base 1970-100) published for Ernakulam Centre. The Workers shall be eligible for Dearness Allowances for the increase in the average. Consumer Price Index Number of the Ernakulam centre for the penultimate 3 months above 400.

The Wage is including ₹ 6.06 of the previous Dearness Allowances (in Tea). The rate of Dearness Allowances shall continue as follows:

- (i) For Adults—₹ 0.065 per point per day.
- (ii) For Adolescents—₹ 0.0515 per point per day.

The supervisors and special categories of employees will be paid D.A. at the rate of ₹ 1.95 for increase over 400 points in the Consumer Price Index Number published for Ernakulam Centre for the previous 3 months. The above D.A. is subject to adjustments on 1st January, 1st April, 1st July and 1st October of every year on the basis of the average Consumer Price Index Number published for Ernakulam Centre for the previous three months beginning 1st July, 1st October, 1st January and 1st April respective!

Full Employment

The minimum rates of wages notified above are based on the assumption that employers in Tea and Rubber Plantation will provide work for their Workers through out the year, failing which the workers shall be given their minimum wages for the days on which they are involuntarily unemployed. But the obligation of the employers is only to offer some kind of work connected with the plantations and worker who refuses to accept that work will automatically forfeit his claim to the wages also. If the employees in any establishment are in receipt of wages higher than the rates said above, they shall continue to receive such higher wages.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Government have decided to revise the existing minimum rates of wages of employees in Tea, Rubber, Coffee and Cardamom Plantations in the State of Kerala as per section 5(1) (b) of the Minimum Wages Act, 1948 after considering the objections and suggestions received on the Preliminary Notification and in consultation with the Minimum Wages Advisory Board. Government have now decided to revise in minimum wages in this industry.

This notification is intended to achieve the above object.
